Receipt details

Register a new bank account

We verify the account is yours by cross-checking: account number, the amount + date of your most recent transfer to the temple, and the name on the bank statement. Family / joint accounts are fine — just give us the name as it appears on the bank account. Your IRD name (set at the top) is used for the receipt itself.

Generate a receipt

Each generation only covers transactions you haven't already been receipted for. If you generate twice in a row with nothing new in between, the second attempt is refused (no point issuing an empty receipt). Older receipts stay valid — new ones add to them, they don't replace.
